To vote for or against a Proposition you must COMPLETELY BLACKEN the oval (●) to the left of your desired response.</p> <p>3. To vote for a candidate on the ballot you must COMPLETELY BLACKEN the oval (●) to the left of the desired name.</p> <p>4. To vote for a candidate not on the ballot you must COMPLETELY BLACKEN the oval (●) to the left of the blank line and write in the name of the candidate and the party affiliation, if for a partisan office, in the space provided.</p> <p>5. TO CORRECT A VOTE, do not erase, cross out error and vote the correct oval. If needed, request a replacement ballot.</p> <p>6. AFTER VOTING – If voting BY MAIL, refold the same way you received your ballot. If voting in a PRECINCT, insert your ballot in the sleeve so that the ballot stub appears at the bottom.
