TRANSPORTATION

WHEREAS, travel upon County Roads by the general public in areas where fire danger exists, greatly enhances the danger of fire being started, and

WHEREAS, it should best serve the public health, welfare and safety during such periods that certain County Roadways be closed to travel by the general public, and

WHEREAS, a request dated June 29th, 2021 was received from the Douglas County Fire Fire Marshal to close three County Roads in the East Wenatchee Area, and

WHEREAS, the Douglas County Fire Marshal has found that fire danger in the area is rapidly approaching the Extreme Fire Danger Classification per the National International Fire Center, now

THEREFORE BE IT RESOLVED, under the authority of Douglas County Code 12.40.010-.030 that as of June 1, 2021 the following Douglas County Roads will be closed until October 1, 2021 to coincide with the county burn ban lifting.

- Blue Grade Road : Sections 23,24,13 T23N R20E
- Doneen Rainey Road : Sections 6, 7, 17 T23N R21E
- Sand Canyon Road: Section 36, T23N, R20E
- Road V S.W. (Bromley Rd.): Sections 5,6,8 T21N R21E
- Road 7.5 S.W. (Bromley Rd.): Sections 8,9,16,17 T23N R21E

Honorable Commissioners:

In response to this year's fire conditions and in the spirit of the prevention of wildland fires for the 2021 season, I would like to request the following roads to be closed to motorized vehicles of any type. Exemptions to these closures shall be granted to local residential, agricultural, and commercial traffic. The recommended road closures will come into effect on June 1 and will be lifted on October 1<sup>st</sup>, 2021 to coincide with the State/County burn ban.

*Blue Grade Road: Sections 23,24,13 T23N R20E*

*Doneen Rainey Road: Sections 6,7,17 T23N R21E*

*Sand Canyon Road: Section 36, T23N R20E*

*Road V S.W (Bromley Rd.): Sections 5,6,8 T23N R21E*

*Road 7.5 S.W. (Bromley Rd.): Sections 8,9,16,17 T23N R21E*
