WHEREAS, the Six Year Transportation Program (2022 – 2027) has been presented to the Board of County Commissioners for their review and approval, and

WHEREAS, said road program was advertised according to the statute and a public hearing was held at 9:30 AM on November 9, 2021, and

WHEREAS, a priority array of potential projects on this County's Arterial System was prepared and available to the Board of County Commissioners, and

WHEREAS, the road fund revenue and expenditure analysis includes the county's best estimates of future road fund revenues and expenditures over each year of the six-year program period, and

WHEREAS, the engineers bridge condition report includes recommendations as to replacement, repair or load restriction for each deficient bridge, and

WHEREAS, all recommendations were heard and public testimony was considered at the hearing, and alterations deemed necessary were incorporated into a final program.

NOW THEREFOR BE IT RESOLVED, that the Six Year Transportation Improvement Program (2022 – 2027) be adopted, said program being on file in the office of the Douglas County Transportation and Land Services Department.


